I LILLIAN REISS of 138 Sinclair Road West Kensington in the County of London Widow hereby revoke all former Wills and Codicils made by me and declare this to be my last Will

1. I APPOINT my dear Son RUPERT ALEXANDER REISS of 31 Lavington Road Worthing in the County of Sussex Retired Advertisement Manager and my Son-in-law BARNET LIBBISH of 1 Grimsdyke Road Hatch End in the County of Middlesex Principal of Catford College of Commerce to be the Executors of this my Will
2. I DO NOT desire that my body should be cremated nor that the corneas of my eyes should be removed
3. I BEQUEATH the following specific legacies free of all duties payable upon or by reason of my death:-
 - (a) To my dear Daughter Audrey Phyllis Libbish all my linen silver plate plated articles and china and such ornaments as she shall desire to have as also the card table and the Singers hand and foot operated Sewing Machine which are in the dining room of 138 Sinclair Road aforesaid
 - (b) To my dear Son Vernon Calvert Reiss my mahogany Writing Desk
 - (c) To my dear Daughter Rita Constance Gortmans the remainder of my furniture my Television Set and all ornaments remaining after my Daughter Audrey Phyllis Libbish has selected such ornaments as she desires to have in or about my residence 138 Sinclair Road aforesaid

WHEREAS by a Settlement dated the ninth day of September One thousand eight hundred and seventy nine and executed on my marriage with my late husband Arthur Montague Reis a testamentary power of appointing the Trust Funds therein comprised amongst the children and issue of my said marriage in such shares and in such manner in all respects as I should think fit was given to me in the event of my surviving my said husband NOW in exercise of the said power and of any and every other power enabling me in this behalf I HEREBY DIRECT AND APPOINT that the Trustee of the said Settlement shall from and after my death stand possessed of the leasehold dwellinghouse 138 Sinclair Road West Kensington aforesaid UPON TRUST for my said Daughter Rita Constance Gortmans absolutely and I express the wish that she shall not sell the said dwellinghouse for a period of ten years after my decease AND I FURTHER DIRECT AND APPOINT that the Trustee of the said Settlement shall from and after my death stand possessed of the residue of the Trust Funds UPON TRUST to divide the same into eighty equal shares and that the said Trustee shall stand possessed of such shares upon the following trusts that is to say:-

- (a) As to twenty-nine such shares to my said Son
Rupert Alexander Reis
- (b) As to a further twenty-nine such shares to my
said Daughter Audrey Phyllis Libbish
- (c) As to two of such shares to my Son Cecil Clive
Reis

(d) As to the remaining twenty such shares to my
said Son Vernon Calvert Reis

5. I DIRECT that any beneficiary given any interest
under the provisions of this my Will who shall in
any way endeavour to dispute my said Will shall
be deprived of such interest
6. SUBJECT to the payment of my just debts funeral and
testamentary expenses I give and bequeath all my
real and personal estate not hereby otherwise
disposed of unto my said Daughter Audrey Phyllis
Libbish



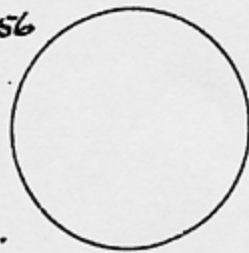
